Welcome to the UK medical register

We're pleased to enclose your certificate for full registration with a licence to practise, which starts on 05/09/2023. Your name will appear on the medical register from that date at www.gmc-uk.org/medreg/. You need to make sure that your registration status is appropriate for your practice.

All doctors practising medicine in the UK must be registered and have a licence to practise. The licence is the part that gives you the legal authority to undertake certain activities, such as practising as a doctor and writing prescriptions. If in the future you give up practice in the UK, you can apply to give up your licence but keep your registration, so that you can demonstrate to others that you are in good standing with us. Maintaining your licence

You will need to revalidate to demonstrate to us and patients that your skills and knowledge are up to date.

To do this, you will need to have an annual appraisal based on *Good medical practice* and collect supporting information, such as feedback from patients and quality improvement activities, to reflect on at your appraisal.

If you haven't already, please tell us your designated body (the organisation that will help you with your appraisal and revalidation) via your GMC online account.

If you haven't got a designated body in the next 30 days, please let us know through your GMC Online account as this will affect the information we request from you. You can read more about this at www.gmc-uk.org/mydb/.

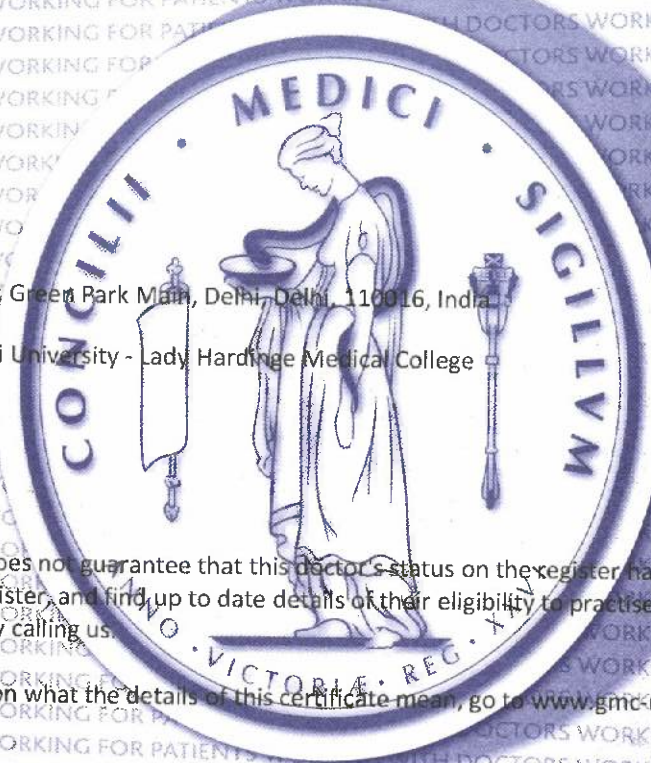
